


Introduction

Port Overview




Item	Description
1. LED Indicator	Indicates a successful power connection
2. USB-A Port	Connects to a USB-A device
3.5mm Audio Combo Jack	Connects to a headset
4. USB-C Port	Connects to a USB-C device
5. USB-C Male (Tethered Cable)	Connects to a laptop
6. USB-C PD Port	Connects to an optional USB-C PD Power Adapter (100W Max)
7. RJ-45 Port	Connects to Ethernet network
8. USB-A Port	Connects to a USB-A device
9. Video 3	Connects to a HDMI or DisplayPort monitor
10. Video 2	Connects to a HDMI monitor
11. Video 1	Connects to a DisplayPort monitor

Powering the Dock

HyperDrive GEN2 12 Port Dock supports bus-powered mode. No external power adapter is required for the dock to work.

External PD power adapter is optional. Up to 100W PD 3.0 is supported.

Connect the Dock to Your Laptop



LED Indicator Guide

The LED light will turn on when HyperDrive is powered in bus-power mode or through an external power adapter.

Multi-Display Support

Up to triple extended display output is supported if the host device supports Multiple Steam Transport (MST).

The 3rd display is either DP or HDMI. If both are connected, DP will have priority over HDMI.

1 extended display: 4K 60Hz* MAX

2 extended displays: 4K 30Hz + 4K 30Hz* MAX

3 extended displays: 4K 30Hz + 4K 30Hz + 1080p* MAX

* Max resolution can be achieved if the host device supports DP1.4 & DSC ON

- Up to 3 Extended Displays are supported on Windows and Chrome OS only as MST (Multi-Stream Transport) is required. macOS does not support MST.
- Up to 3 Mirrored Displays are supported on Windows, Chrome OS and macOS.
- 4K 60Hz requires that your USB-C port supports DP 1.4 and DSC.
- Full dock functionality depends on the host computer's capabilities. Please contact your host device manufacturer to confirm external display, host charging, and USB device support.
